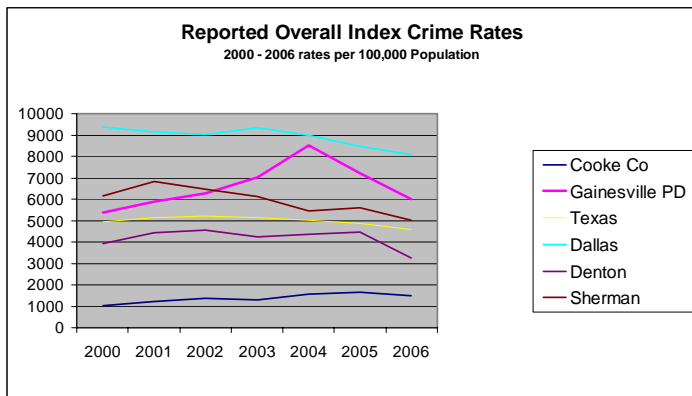
# Re-Elect Republican D.A. Cindy Stormer
